# Mobile Phone/Electronic Games Policy

# **Introductory Statement:**

This policy was drawn up in response to technological advances, which have seen a significant increase in hand held electronic 'gadgets' amongst the school population over recent years.

### Rationale:

- Ipods, Mobile Phones, Game Boys, PSP's, MP3's or any other recording device etc. are intrusive and distracting in a school environment.
- Strategies must be put in place to reduce the intrusiveness of unauthorised technology in a school situation.
- Some electronic devices may be harmful due to frequent use.
- Mobile phones may be used to conduct bullying campaigns.

### **Relationship to School Ethos:**

The use of mobile phones and other electronic games contravenes the provision of a safe and secure school environment and is not conducive to learning – a provision which is central to the mission statement and ethos of St. Fergal's National School.

### Aims:

- To ensure the health and safety of pupils and staff and other members of the School Community.
- To lessen intrusions on and distractions to children's learning.

# **Internal School Procedures**

The following are guidelines for mobile phones/electric games usage/smart watches in the school.

- 1. Children are not allowed the use of mobile phones/electric games/smart watches during school hours or when they are on the school premises.
- Phones, smart watches or any electric games are not allowed on school trips.
   Teachers will contact the school directly if there is a delay or if a parent/guardian needs to be contacted
- 3. It is our preferred option and we recommend strongly that if at all possible no mobile phones are brought to school.
- Children who need to contact home during school hours may do so through their class teacher. Staff have access to the school landline if urgent calls need to be made to parents.

The following procedure is in place for any breach of these by a student:

- 1. The phone will be confiscated
- 2. It will be held by the principal.
- 3. Student and parent/guardian will be invited to discuss the breach of policies with principal before the phone can be returned.

If it is deemed necessary for the phones to be collected, the school accepts no responsibility for any loss or damage or the phones.

- Despite the foregoing, any parent who still wishes their child to have a mobile phone in school must sign the attached Authorisation Form which ensures that:
  - (a) the mobile phone will remain powered off (not on silent or vibration alert) at all times on school premises and during the school day.
  - (b) that if a child's phone is powered on during the school day it will be confiscated and the child's parents must come to the school in person to retrieve it.
  - (c) accepts that if a child's phone is stolen or damaged while on school premises the Board of Management will not be liable for any loss or damage.

# **Evaluation**

The policy is monitored on an ongoing basis and amendments added as new technology comes on stream.
